## TENNESSEE NOTARY PUBLIC APPLICATION FOR WILSON COUNTY

This application must be filled out in its entirety and **signed under oath in the presence of a Notary Public** and submitted to the county clerk's office for approval by the Board of Commissioners, which meets on the 3<sup>rd</sup> Monday night of each month. Call 443-2627 to see if you were approved. Once elected you must then be commissioned by the Governor. If elected, you will be required to post a bond in the amount of \$10,000. The bond must be filed in the office of the County Clerk, who will accept the required fee of \$12.00 (notary commission) and administer the oath of office. You are not required to purchase a notary seal from our office, but we can order you one for \$28.75. You are not authorized to act as a Notary Public until you have received your commission from the Governor, filed your bond, and taken the Oath of Office. **If you move your residence or your principal place of business out of this county, you are required by law to notify the County Clerk of the change of address.** Pick up change of address form from county clerk's office.
